

**VILLAGE OF MOUNT PROSPECT
APPLICATION FOR 2025 PROPERTY TAX RELIEF GRANT**

Any current resident of the Village of Mount Prospect who is the **owner and occupant** of a single-family residential unit and whose income does not exceed certain income guidelines may be eligible for a Property Tax Relief Grant as authorized under Article XIV of Chapter 8 of the Mount Prospect Village Code.

To qualify for the 2025 grant, the maximum income for a one-member family unit is \$30,120. The maximum income for a family unit of two or more is \$40,880. The grant amount will be fifty percent (50%) of the portion of the 2024 real estate property tax, up to a maximum of \$250.00, levied by and on behalf of the Village and paid by the applicant.

A copy of the 2nd installment of your 2024 Real Estate Tax Bill, a signed copy of your 2024 Federal Income Tax Return (if filed), and a copy of your Social Security benefit statement (Form SSA 1099) for 2024 must be included with this application.
