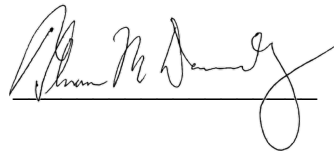
ORDER

THIS MATTER having come before the court for presentment of City's Motion to Strike, Prestige's Motions for Leave to File an Amended Complaint and Motion to Compel and the Village's Motion for Leave to File a Fourth Amended Counterclaim, all parties being present in court and the court having being fully advised in the premises,

IT IS HEREBY ORDERED THAT:

1. City of Des Plaines' Verified Petition for Rule to Show Cause is withdrawn.
2. City of Des Plaines' Motion to Strike Certain Paragraphs of Prestige's Affirmative Defenses is granted. Prestige shall file amended affirmative defenses to the City's intervening complaint within 7 days. City shall file an answer to the affirmative defenses within 7 days thereafter.
3. Prestige's Motion for Leave to File an Amended Complaint is denied for the reasons stated in open court.
4. Village of Mount Prospect's Motion for Leave to File a Fourth Amended Counterclaim is unopposed and granted. Village has leave to file the fourth amended counterclaim *instantly*. Prestige shall answer or otherwise plead to the Village's Fourth Amended Counterclaim within 28 days.
5. Prestige's Motion to Compel Village of Mount Prospect Discovery Compliance is granted. Mount Prospect shall respond to the supplemental discovery requests within 14 days.
6. Prestige shall issue a settlement demand to the Village of Mount Prospect within 28 days of this order. The Village shall respond to Prestige's settlement demand within 7 days thereafter.
