## Outdoor Dining Application Cont'd

Proof of Insurance: If the outdoor dining area is on the sidewalk or public right-of-way, you must provide evidence of general liability insurance and dramshop insurance, if applicable, naming the Village of Mount Prospect as an additional insured and insuring the Village against any liability resulting from the uses permitted by the Village. Minimum coverage for general liability insurance and dramshop insurance shall be as set forth in Appendix A, Division I of the Village Code, and shall have no less than an "A" rating by the most recent AM Best Insurance Rating Guide.
