Mount Prospect Police Department Arrest Person for Predatory Criminal Sexual Assault



Amado Gonzalez-Sanchez

On May 5, 2022, the Mount Prospect Police Department arrested and charged Amado Gonzalez-Sanchez, 50 years old, of 145 Dover Drive, Des Plaines, Illinois with two felony counts of Predatory Criminal Sexual Assault and one felony count of Aggravated Kidnapping. These charges stem from an incident that occurred behind the business at 1843 West Algonquin Road, Mount Prospect.

On May 5, 2022 at approximately 4:56 PM, the Mount Prospect Police Department responded to 1843 West Algonquin Road for an investigation of a criminal sexual assault involving a juvenile victim. Upon arrival, officers learned Amado Gonzalez-Sanchez had met a 12 year-old juvenile victim outside of the business at 1805 West Algonquin Road and led the juvenile into the back alley behind 1843 West Algonquin Road. Gonzalez-Sanchez forced the 12 year-old juvenile to have sexual contact with him by verbally threatening the juvenile. A witness observed Gonzalez-Sanchez and the juvenile in the back alley and called 911. Mount Prospect Police Detectives were able to locate surveillance video of the back alley, which contained evidence of the crime.

The Cook County State's Attorney's Office approved charges against Amado Gonzalez-Sanchez of two (2) felony counts of Predatory Criminal Sexual Assault and one (1) felony count of Aggravated Kidnapping.

Gonzalez-Sanchez was transported to a bond hearing on May 7, 2022, where his bond was set at \$500,000.00 "D". The next court date for Gonzalez-Sanchez is set for May 11, 2022 at the Cook County 3rd District Courthouse in Rolling Meadows in room 108 at 9:00 AM.

The public is reminded that criminal charges are not evidence of guilt and that all defendants in a criminal case are presumed innocent unless and until proven guilty in a court of law.
