## NEWS RELEASE Mount Prospect Police Department Charge Man with Burglary



**Armond Adams** 

On September 3, 2023, Mount Prospect Police Detectives charged Armond Adams, 20 years old, of 3142 West Fillmore Street, Chicago, with one felony count of Burglary. This charge stems from a commercial burglary that took place at the business at 2445 Oakton Street on February 7, 2023.

On February 7, 2023 at approximately 1:51 AM, the Mount Prospect Police Department responded to a 911 call of a commercial burglary in progress at 2445 Oakton Street. The complainant, who was watching via security cameras at the business, reported approximately 5 subjects in the business at that time. While officers were responding to the business, the complainant advised the offenders left the property in a black colored SUV. Upon the arrival of officers at the business, damage to a one of business entrances was discovered and areas of the business were ransacked. The owner of the business responded and was able to identify property of the business had been taken by the offenders. Crime scene technicians processed the area and business for any evidence and located potential DNA evidence at the scene. The evidence was sent to a crime lab, which determined the evidence containing the DNA sample taken from the burglary scene belonged to Armond Adams. Detectives attempted to locate Adams multiple times at his residence, but were unsuccessful. An arrest warrant was issued for Adams related to this burglary. On September 2, 2023, the Mount Prospect Police Department was informed by the Chicago Police Department that they had Armond Adams in custody on the arrest warrant.

On September 3, 2023, the Cook County State's Attorney's Office approved one felony count of Burglary charge against Adams.

Adams was transported to a bond hearing on September 4, 2023, where his bond was set at \$25,000.00 "D". His next court date is scheduled for September 29, 2023 at 9:00 AM in room 108 of the 3<sup>rd</sup> District Court of Cook County in Rolling Meadows.

The investigation into this burglary is still open and on-going to identify any additional offenders.

The public is reminded that criminal charges are not evidence of guilt and that all defendants in a criminal case are presumed innocent unless and until proven guilty in a court of law.
