

# **Executive Summary**

The 2023 Public Works Department Strategic Plan is a roadmap to achieve Mount Prospect's mission to advance our community's quality of life and potential through adaptive leadership and leading-edge service delivery. The Public Works plan relates to the Village's strategic planning goals and objectives to focus efforts and track progress through an organized means to accomplish operational work performed by the department.


The Strategic Plan outlines the implementation process and highlights the activities/milestones established to track and monitor progress for significant projects, programs, and critical initiatives. We selected the challenges and opportunities that allow the department to maneuver potential obstacles and identify additional favorable circumstances that may appear through an advanced planning effort for a given project or program. Direct outcomes may establish relevant initiatives to target due to the design and scope of planned work. This plan is reviewed and revised annually to encourage innovative thinking and remain a continuous effort for the department.

Though this plan was first developed as a product of the department's process to become an American Public Works Association (APWA) Accredited Agency, it is recognized as an imperative tool to implement and attain specific goals and objectives outlined yearly. The next five years will guide employee actions, determine resource allocation, and stimulate meaningful collaboration across the organization. Moreover, this document aims to establish realistic expectations and act as a blueprint for Public Works operations to be more effective, efficient, and creative regarding possible municipal service delivery.



# **Organizational Structure**

The Department of Public Works comprises six operational divisions: Administrative, Engineering, Water & Sewer, Streets & Building, Forestry & Grounds, and Vehicle Maintenance. There are 65 full-time, three part-time, and eight seasonal employees for 76 total. The full-time, part-time, and seasonal personnel assigned to maintenance functions are interchanged between the Water & Sewer, Streets & Buildings, and Forestry & Grounds Divisions as necessary.

The Fairview Sanitary Lift Station services the Fairview Gardens subdivision sewer system. Fairview Lift station is due for rehabilitation, but MWRD is requiring the Village to reduce the capacity of the lift station. Reducing the capacity of the lift station will result in basement backups. The ability to successfully reduce the station's capacity is predicated on removing clear water from the sanitary system. The Village has lined all sewer mains and manholes in the subdivision, eliminating all infiltration into the public system. However, 96 homes in the subdivision have footing tiles directly tied to the sanitary sewer via their home's sewer lateral.
