Building the Proper Foundation from the Start:

Begin with the End in Mind: Where do I want to be in 10, 20, 30, years?

What does an ideal exit look like?

- What should we be? Choice of Business Entity
  - (Sole Proprietorship, LLC, Corporation, Partnership)
    - Some considerations are tax driven, some by the number and type of participants/owners, and some are liability driven
      - LLC, S Corp, C Corp
    - An entity of some kind is usually preferable
      - Provides limited liability if set up and maintained properly
      - Separate Business from Personal
    - Set it up thoroughly and correctly the first time, especially with multiple owners. Think about what happens when somebody dies, retires, gets divorced, wants out.
      - Buy/Sell Agreement, Dissolution, Sale of the Business, Dispute Resolution
      - Initial, thoughtful planning at the beginning helps avoid disputes in the future.

How to protect yourself and your assets when starting a business

- A limited liability Entity (LLC, Corporation are most common)
- Keep your Accounting and your Money Separate Don't commingle business income and assets with personal income and assets.
  - Proper set up and maintenance = better asset and liability protection
    - Follow the formalities, Meetings, Documentation of Corporate Actions
    - Protects against internal disputes and external liabilities
  - Failure here can result in loss of limited liability status
  - Set up a business and act like a business.
  - Get adequate insurance for the type of business you need (Consult an Insurance Broker)
  - Consider personal umbrella coverage.

How to ensure you are compliant in your state:


- Get some good legal and accounting advice early. Set up your accounts with the IRS and IDOR. Make sure to be timely with your payroll and tax filings
- New: Corporate Transparency Act Filings -Disclosure of Beneficial Owner (real people)
- File your annual reports (But that's not all)
- Understand Mandatory Insurance Coverage: E.g. Worker's Comp Coverage. Get it. Consult your Insurance Broker. Your worker's comp broker can also provide you with compliance material.

### Insurance:

- Evaluate the Risks and Cover Accordingly
  - Basic Business Liability Coverage
  - Other coverage based on the specifics of your business. What risks are involved?
  - More Coverage is better than less.
  - Specific Coverages for Specific Projects.
     Lean on your broker, but when in doubt, get a legal opinion about the specifics of the policy. They are complicated.


