# News, Notes and Reminders

#### Water Rate Increase

The Village Board recently approved a 9.5% increase to water and sewer utility rates. The larger than usual increase to the water rate is necessary to cover the higher cost expected for water purchases. The City of Chicago, which provides water to the Village through the Joint Action Water Agency, has scheduled a series of excessively large rate hikes. A 25% rate increase took effect on January 1, 2012. Hikes of 15% are planned for each of the next three years. The rate increase planned for the village is primarily to cover the higher cost of water. The current combined rate for water and sewer is \$7.69. Effective with all billings after January 1, 2013, the new combined rate will be \$8.42. A Mount Prospect household typically uses 8,000 gallons of water over a one-month period. Based on this estimate their monthly water and sewer usage fee would be \$67.36, an increase of \$5.84. This includes the \$5 monthly sewer construction charge. There was no change in the sewer construction flat fee. For more information please contact the Water Billing Department at 847-392-6000.

### **Remove Holiday Decorations**

Keep your home safe! Village Code requires holiday decorations be removed within 60 days of the holiday. Besides aesthetics, there's a safety value in removing these items. Remember, the lighting and electrical devices for outdoor

displays are designed for temporary installation. Insulated wiring exposed to the wind, rain, sun, snow, and cold can wear and crack, increasing

the risk of an electrical short and a possible fire.

### **Energy Impact Illinois**


For a limited time, the U.S. Department of Energy and local utilities and nonprofits are together offering a cost-saving program called Energy Impact Illinois to all Chicagoland homeowners to make their homes more comfortable and energy efficient. To determine your home's needs, the program is offering a home energy assessment for \$49 to Nicor customers, and an instant rebate of 70% (up to \$1750 off) on insulating and air sealing (the most cost- and energyeffective improvements). Energy Impact Illinois is also providing access to lowinterest loans (free first-year interest on loans greater than \$2500) for boilers, furnaces, windows or other energy efficiency improvements. #### Vehicle Stickers

The deadline for displaying the 2012-2013 vehicle stickers was April 30, 2012. The Police Department issues citations to drivers of locally registered vehicles if the 2012-2013 vehicle sticker is not displayed. Vehicle stickers purchased after April 30 are subject to a late payment penalty. The penalty does not apply to new residents/businesses or to those who have purchased replacement vehicles after May 1. In these situations, there is a 30-day grace period in which to purchase a sticker. Proof of move-in or vehicle purchase date is required to ensure that a penalty is not imposed. If you change vehicles during the year, call the Finance Department at 847-392-6000 for more information.

If you purchased a vehicle sticker in 2012, you should be receiving a renewal notice in the mail during the first week of February 2013. If you recently moved to the Village or if you do not receive your renewal notice by February 11, 2013 please come to Village Hall to pick up a renewal application. - You must present two forms of identification with at least one showing your current address.



# Where do **Property Taxes Go?**

The Village of Mount Prospect provides a complete range of services for its residents and business community. They include police and fire protection, street and highway maintenance, health and social services, refuse disposal, public improvements, planning and zoning, engineering and inspection, water and sewer utility service and general administrative services.

To pay for all this, the Village obtains revenues from a number of sources, including property taxes. Property taxes accounted for 22.0% of the Village's total revenues expected for 2012. Sales tax, service charges, licenses, fees, state income and motor fuel taxes, and several other revenues sources make up the balance. The Village uses the money it receives from property taxes for four basic purposes: police and fire protection, public safety pensions, refuse disposal and public improvements.

The owner of a residential property in Mount Prospect having an equalized assessed value of \$103,500 (approximate market value of \$350,000) will pay the Village about \$917 in property taxes as a result of the final 2011 levy (payable in 2012). Of this amount, \$436 is for police and fire protection, \$272 is for funding public safety pensions (police and fire) pensions, \$106 is for refuse disposal, and \$103 is for public improvements. This estimate assumes only the standard homeowner exemption when determining taxable value. Homeowners may also be eligible for the senior citizen exemption, senior freeze or other property

tax exemption offered by the Cook County Assessor's Office. These programs work to provide further relief to the annual tax bill.

#### **Other Taxing Districts**

Within and including the Village of Mount Prospect, there are 34 separate and independent taxing districts. They include the Mount Prospect Public Library, Cook County governments, Metropolitan Water Reclamation District, six (6) public school districts, five (5) park districts, and fourteen (14) other tax districts, plus Elk Grove and Wheeling townships.

With the exception of the Village and Public Library, the taxing districts in Mount Prospect do not share common boundaries. As such, not all of the 34 tax levies appear on every tax bill for a Mount Prospect resident or business. Typically, there are 16 or 17 districts on each individual tax bill.


#### Village's Share.

The chart below shows the breakdown of property taxes for the Village of Mount Prospect in Elk Grove Township from the 2011 tax bill (payable in 2012). The Village is to receive \$15.9 million or 11.4% of the total. The percentages vary depending on the area of the Village and the taxing districts included.

# Can't Afford Replacement? Maybe We Can Help.

Mount Prospect has loan and grant programs available to assist homeowners with performing energy efficient improvements to their property. Loans are available to low and moderate-income Mount Prospect residents who have owned and occupied their home for a minimum of one year and can be used to correct housing code violations, increase energy efficiency, make improvements for disabled persons, and more. The Village's Single-Family Rehabilitation Loan Program provides an interest-free loan up to \$25,000 for repairs. The loan is repaid to the Village upon the sale or change in title of the property. The Home Weatherization Grant Program provides a \$1,500 matching grant assistance for similar projects. The following are some common questions regarding these programs:

### Where does the money come from?

The Rehabilitation Loan and Grant Programs are funded through Community Development Block Grant (CDBG) funds allocated by the U.S. Department of Housing and Urban Development (HUD).

# How do I know if my income qualifies?

The Village uses the Adjusted Gross Income from the previous year's Federal Tax Form. HUD's income limits, which are based on the total income of all people living in the home, change on an annual basis. The 2012 household income limit for one person is \$42,500, 2 persons \$48,550, 3 persons \$54,600, 4 persons \$60,650. See our website for a complete list for households in excess of four persons.

# Downtown Planning **Process Continues**

The Village of Mount Prospect, the Lakota Group and The Regional Transportation Authority (RTA) are continuing the Downtown Implementation planning process to complete an assessment of downtown Mount Prospect. The overall purpose of the plan is to determine how the downtown area can continue to transform itself and improve in the years to come. The study is intended to reevaluate the area and provide a detailed implementation strategy to support the future success of downtown Mount Prospect.



Over thirty residents attended the first Community Workshop held on September 14, 2012. Additionally eighty residents participated in a survey which was provided online. The Village thanks everyone for their participation! Your feedback will help develop the vision for the future of the downtown area.

A second Community Workshop is expected to be held near the beginning of February, 2013 (date TBD). Residents and business owners are welcome to attend this and future open house discussions as the process moves forward.

### **Apartment Heat - 68 Degrees**

During the winter months the heat in apartments is required to be kept at a minimum of 68 degrees throughout the day and night. If your apartment is below 68 degrees, contact your landlord to correct the problem. To prevent fires and deadly build-up of carbon monoxide do not use the stove or a space heater to heat the apartment.



To prevent heating problems and help the heating system warm your apartment efficiently

and evenly, keep furniture away from heat registers, close all windows completely, and seal openings, such as air conditioner sleeves, weather-tight. To prevent the build-up of frost on drapes and window curtains, all curtains and drapes should have space between them and the wall and opened as needed to prevent frost build-up. If your windows remain drafty after closing completely or frost builds up regardless of your efforts to move the drapes and curtains, the windows may need weather stripping or repairs. Contact your landlord for repairs. If the landlord does not make repairs or adjust the heat, call the Community Development Department at 847-870-5668.

# **Protecting Your Investment:**

# The Importance of Building Permits and Inspections

People sometimes ask why it is important to get building permits for construction work, but avoiding permits can create life safety hazards and even affect the value of your property. Frequently, we hear concerns about the Village requiring permits for items such as water heaters, furnaces, air conditioners, and generators. While it may seem tedious, the Village specifically requires permits on any project that involves gas, electricity, and/or water for our resident's safety. Final inspections are performed to ensure that your contractor performed the work and/or installed your new mechanicals correctly.

Every year, the Mount Prospect Fire Department is called out on carbon monoxide alarms at single family homes. The deadly gas is commonly found leaking from water heaters, or other mechanical appliances installed without a permit. The improper installation of these appliances did not allow for sufficient ventilation of the poisonous gas and causes a potentially deadly situation for the homeowners; something that an inspector would have recognized during inspection and ordered the contractor to remedy immediately.

Most importantly, inspections are conducted to protect life safety; however, permits and inspections are also important in protecting the value of your investment. For instance, if you install a gas fireplace without a mechanical permit and your house burns down because of faulty installation, your insurance may not cover the damage.

When it comes time to sell your home, permits and inspections can help validate the value of your home. Many times appraisers ask for verification that the improvements were, in fact, done with permit. If the sellers cannot substantiate that the work was done with permits, the appraiser might not give full value for the improvements. If the house doesn't appraise for the sale price, your sale could be in jeopardy.

### Holds Placed on Real Estate Transfer Stamps

The Village can place holds on Real Estate Transfer Stamps for a variety of reasons including open or incomplete Building Permits. The Building Division will place a hold on a property that has a permit that has not passed a final inspection, obtained a certificate of completion or a certificate of occupancy. This is done to ensure the safety of our residents. In light of the current economy, we will work with a buyer to remedy any outstanding issues. Potential buyers are encouraged to complete a Freedom of Information Act (FOIA) request through the clerk's office to see if there are open permits or other items that may delay the sale of a real estate transfer stamp.

### Aluminum Wiring Safety

Village of Mount Prospect recommends that all homeowners and property owners check all wiring, including branch circuits, to assure safe and secure operating conditions. In particular, aluminum wiring should be regularly evaluated by Licensed and Qualified Electricians to make sure all connections and electrical devices are operating correctly and safe. # Emerald Ash Borer Continues to Ravage Ash Trees

### 2012 Review

Village arborists continued to find Emerald Ash Borer throughout Mount Prospect in 2012. Unfortunately ash tree losses continued to grow exponentially throughout the year. More than 600 infested parkway ashes were removed in 2012, up from 171 trees in 2011 and 23 trees in 2010.

Property owners are still asked to report to Public Works any ash trees showing EAB symptoms. The most common symptoms are branch dieback, bark splits, suckering and D-shaped emergence holes. Also, in late Winter/early Spring before infested ashes leaf out, woodpecker damage often becomes fairly

evident, especially on upper limbs. (Photos of these symptoms can be seen at www.mountprospect.org).

### **Management Strategies**

The Village began preparing for EAB shortly after it was first identified in Michigan in 2002. Mount Prospect's Village Board adopted an EAB management plan in 2009. The plan utilizes a number of strategies. Prior to any known infestation in Mount Prospect, the Village completed an ash reduction program to remove and replace poor quality parkway ashes as well as those in poor growing sites. Preventive insecticidal treatments were also begun on select trees. Once EAB was found in the Village in late 2010, the focus shifted to removing and replacing infested trees. Presently Village arborists are constantly on the lookout for EAB symptoms as they carry out their daily duties. In addition, a thorough tree by tree survey is now conducted each winter. In this survey every parkway ash tree in neighborhoods due for cyclic pruning the following year is closely inspected before pruning begins, and infested trees are scheduled for removal. In this way the Village does not waste money pruning trees that are already infested.

Additionally, Village code requires prompt removal of infested private property ash trees, at the property owners' expense. Removal of these trees may be delayed if the tree is being actively treated with an approved EAB insecticide and does not pose a threat to users of the public right-of-way.

In addition to removing/replacing infested parkway ashes, the Village continues to preventively treat with insecticide approximately 800 parkway ash trees throughout Mount Prospect. Trees in the treatment group were chosen based on species, size, condition, and health; the group is primarily composed of white and blue ash trees in good condition and larger than 7" in trunk diameter. Smaller ash trees were left out of the treatment group because they can more easily be replaced without significant loss of canopy. Green ashes were not included because of their higher likelihood of branch failure, as well as their greater susceptibility to EAB infestation.

### **Insecticide Treatment Options**

In 2012 the Village Board agreed to formalize a permit process that allows property owners to treat parkway ash trees in front of their homes, at the property owner's expense. Property owners wanting to treat a parkway ash tree must first contact Public Works to obtain a free treatment permit.

The Village urges property owners wishing to treat ash trees, either public or private, to start the treatment process as soon as possible. Treating a tree before it becomes heavily infested greatly increases the likelihood that the insecticide will be effective in prolonging the tree's life. It is generally thought that treatments will have to be continued for the life of the tree as EAB will more than likely remain a constant pest in Illinois. Most products currently being used require application every year or every other year. Treatments can generally be done anytime during the growing season, but individual product labels should be referenced for optimum timing. A number of products are available and a certified arborist can assist you with available treatment options. Some products are even available for homeowners to apply themselves to smaller trees, but trees larger than 15" in trunk diameter should be treated by a contractor. Additional details about treatment options are also available on the Village website.

## Reforestation Efforts



The Village has attempted to maintain its parkway tree planting efforts by taking advantage of grants over the past two years. In 2012 a grant received through the Metropolitan Mayors Caucus, as well as Community Development Block grant funds, allowed the planting of many new  $1\frac{1}{2}$ " diameter trees. Additionally, many Mount Prospect residents contributed their own funds to upgrade to  $2\frac{1}{2}$ " diameter replacement trees. In 2012 nearly 800 new parkway trees, of many diversified species, were planted Village-wide.

As of this writing in November 2012, it is unknown if additional grant funds will be available in 2013. The Village's full cost planting program will definitely continue in both Spring and Fall. On this program property owners can take advantage of the Village's contract pricing for 2 ½" diameter parkway trees, which includes planting and a one year guarantee. Interested parties should contact Public Works by March 1 for ordering information for Spring planting.

Property owners can also beautify Village parkways by planting trees on their own, but only with an approved Village permit. Planting permits are available through the Public Works Department at no cost. All Village code requirements must be met, including having a suitable planting site, planting a minimum  $1 \frac{1}{2}$  diameter tree, and choosing a species approved in the Village Code. Note that "suitable planting site" means that certain minimum conditions are met, such as spacing between trees and required distances from driveways, utilities etc.

Finally, the Village also continues to encourage property owners to plant diversified tree species on their private properties throughout Mount Prospect. The Village website offers species selection ideas; look for Increasing Tree Diversity in the Urban Landscape under the Forestry/Grounds tab.

### Gypsy Moth Populations Moth Populations Appear to be Very Low

The Village's arborists had a little good news in summer 2012, as they encountered very little tree damage due to Gypsy Moth. As of this writing, in November 2012, it appears the Gypsy Moth population in Mount Prospect is significantly down from what it was several years ago. Unless staff finds significant Gypsy Moth egg masses this winter, the Village may not need to apply any treatments for this pest in 2013.



### Movement of Firewood Spreads Invasive Pests

For residents who use firewood, the Village encourages you to burn all of the wood before April. Gypsy Moth, EAB and other invasive pests are easily spread by firewood movement. If you purchase firewood to heat your home, make sure it comes from a vendor certified by the Illinois Department of Agriculture or has a compliance label from the USDA. Also, make sure any tree care companies you hire to work on your private ash trees can produce a signed Illinois Department of Agriculture "EAB Compliance Agreement."





### **Mailbox Policy and Damage**

Mailboxes physically hit by a Village snowplow or truck, will be replaced by the Village at no charge. Mailboxes that are damaged by snow thrown from snow plowing operations are the responsibility of the homeowner to repair, but the repair costs are eligible for reimbursement by the Village. To be eligible for reimbursement the mailbox must be installed per Village code. Please visit the Village website at www.mountprospect.org to view mailbox installation guidelines. The Village will provide a temporary mailbox until weather allows for repairs to be made. Most importantly, if your mailbox is

damaged during snow plowing operations, please contact the Public Works Department before making any repairs.



### **Snow Parking Reminder**

After a minimum 2-inch snowfall, parking isn't permitted on any Village street for at least 24 hours. This ordinance supersedes any overnight parking permission that previously may have been granted. Illegally parked vehicles will be towed by the Village to allow for snow removal crews to plow the streets. The cost of the towing will be borne by the vehicle owners. It is each vehicle owner's responsibility to monitor the weather conditions and to avoid problems if a 2-inch or greater snowfall occurs, regardless of the time of day.


## Winter **Tips**

### **Snow Shoveling**

Please remember that it is hazardous to shovel, plow, or blow snow onto any public street. All shoveled, plowed, or blown snow should be piled in your yard or parkway. Please follow the suggestion below to minimize windrows in your driveway opening.

- Shovel the snow to the side, in the direction of traffic, and clear a pocket of snow on the opposite side of your driveway.
- The accumulated snow in the plow will dump into the pocket and NOT in your driveway.
- This simple procedure will minimize the amount of residual snow being plowed from the street into your driveway.





### When will my street be plowed?

Since all streets can't be plowed at the same time after a snowfall, there is a priority system.

- 1. Principal intersections are plowed and salted first.
- 2. Primary collector streets are then plowed enough to allow two-way traffic to pass safely. Cul-de-sacs are plowed after a 2- inch accumulation of snow.
- 3. Feeder streets and dead ends are plowed last.
- 4. When all roads have been opened, repeat passes will be made to clear them curb-tocurb, and intersections also will be cleared completely.



## Solid Waste Notes

### Holiday Light and Extension Cord Recycling Program

Did you purchase a new set of Holiday lights this year, and don't know what to do with your old lights? Do you have a set of Holiday lights or extension cord that you can't get to work? Don't throw them in the garbage. You can recycle them free of charge.

The Village is accepting unused and non-working Holiday string lights and extension cords. The materials in the string lights and extension cords will be reclaimed and reprocessed into new products. Most importantly they will be kept out of the landfill.

Residents can drop off their unwanted Holiday string lights and extension cords at the Public Works Department located at 1700 West Central Road between the hours of 7:30AM and 5PM, Monday - Friday. The program started November 1st with a tentative end date of February 28th. Call (847) 870-5640 for more information.

The Village cannot accept garland, live greens, wreaths, or other non-recyclable materials.



### Caring for your Vehicle and the Environment

Proper car care and maintenance is a very important part of efforts to protect the local environment. Many vehicle fluids can be hazardous to waterways. Whatever is dumped into storm drains or onto pavement will wind up in local creeks and, ultimately, in the Des Plaines River.

If you change your own oil, it is very important that it is disposed of properly. Put the used oil in a sturdy container, label it, and take it to a local oil recycling location. Call Public Works (847/870-5640) for a current list of oil recycling stations.

Antifreeze is also dangerous to the environment. It contains ingredients that are poisonous to people, fish, and wildlife. It should be treated in the same manner as waste oil. In the case of a spill involving any of these types of materials, use kitty litter, sawdust, cornmeal, or special oil absorbent products to absorb the spill. Sweep up the absorbent after a few hours. For more information about household hazardous collection events, visit the Village website.

### **Christmas Tree Collection**

Residents are encouraged to participate in the Village's Christmas tree composting program. Christmas trees will be collected by the refuse hauler at no additional cost on your regular refuse collection day; no stickers required.

Christmas trees set out for composting must be free of all decorative debris. Please remove all decorative items from the tree including:

- Lights
- Tinsel
- Ornaments/bulbs
- Strings/wires

Please do not cut or trim trees for collection, place trees at the curb whole. Trees may be placed at the curb prior to December 31 and after January 11, but these trees will be collected as regular refuse and will not be composted. Wreaths will also be collected at no additional cost on your regular refuse collection day, but are considered refuse due to the metal frame. Please place your wreath in your green refuse cart for disposal. In addition, artificial wreaths are not recyclable. Artificial wreaths should be placed in the green refuse cart for disposal not the blue recycling cart.





# Fire Department Gives Back

### **Fireplace Safety**

In 2012, the Mount Prospect Fire Department responded to two home fireplace fires. To help reduce the risk of fireplace fires, the Fire Department recommends that residents follow these guidelines for proper use and maintenance:

### **Keep Fireplaces Clean**

- Have your chimney thoroughly cleaned and inspected at least once a year. Make sure that the flue is carefully inspected both inside and out.
- Burn only hard woods as they contain smaller amounts of creosote, a black tarry substance that can block passageways and/or easily ignite.
- Put cool ashes in a metal container when you clean out your fireplace.

#### Safely Burn Fuel

- Never leave a fire in your fireplace unattended.
- Burn only seasoned firewood.
- Never burn paper, charcoal or rags.
- When using artificial logs, burn only one at a time.

#### **Protect Your Home**

- Keep flammable and combustible articles at least three feet away from the open fire.
- Make certain that your smoke detectors are working.
- Always use a fireplace screen in front of your fireplace.
- Supervise children at all times when using your fireplace.

Contact the Mount Prospect Fire Prevention Bureau at (847) 818-5253 with any questions. Finding ways to give back to the community, and the greater Chicagoland area, was a priority for the Fire Department in 2012:

• On July 11, Fire Department personnel partnered with a local non-profit organization, Operation North Pole, to participate in the "Meals from the Heart" program at the Ronald McDonald House located at the University of Chicago Comer Children's Hospital. Employees prepared a "good old fashioned barbeque" for the families staying at the house.



- In late July, The Mount Prospect Fire Fighters Union Local 4119 raised \$4,500 for the Muscular Dystrophy Association.
- The Susan G. Komen 3-Day Breast Cancer walk came through Mount Prospect on August 11 and the Fire Department personnel in pink t-shirts joined the entire community in cheering them on.
- In August, the Mount Prospect Fire Fighters Union Local 4119 donated nine backpacks filled with school supplies to the Village's school supply drive for local families struggling financially.
- On August 24, the Fire Department delivered over \$6,000 worth of paper goods and household products to the Ronald McDonald House at the University of Chicago Comer Children's Hospital. Donations came from Fire Department employees and a local company, Multi-Pak Solutions.
- On October 27, the Fire Department sponsored a food drive for the Village's Emergency Food Pantry.
   Fire Department personnel accepted donations outside of Costco and Jewel at Randhurst Village. The department collected over \$16,000 worth of food, toiletries, diapers, and cash and gift card donations.
- In December, the Fire Department partnered with the Human Services and Police Departments for the Village's annual toy drive for underprivileged families. Fire Department employees also took up a collection internally to purchase gifts for two children participating in Operations North Pole's "fantasy trip to the north pole" event.

# Unlocked Vehicles an Open Invitation For Criminals

Car burglaries are very difficult cases to solve as there is usually very little physical evidence left behind after one has occurred. Recently, 58% of thefts from vehicles in Mount Prospect have been occurring due to vehicles being left UNLOCKED. In order to help reduce the risk of becoming a victim of a car burglary we are providing some easy tips to follow:

- Always close your windows and lock your doors. An open window or unlocked door is an invitation to a criminal.
- Remove loose valuables from your vehicle. A car burglar loves to see items that can
  be grabbed easily and carried away without much effort. G.P.S. devices and radar
  detectors are popular items for car thieves. Also remove any accessories for your
  valuables as well.
- If you must leave valuables in your car place them out of sight in the trunk or under the seats.
- Don't hesitate to call 9-1-1 to report suspicious persons seen wandering around
  in parking lots or driveways or looking into cars as they walk by (your call can by
  anonymous).
- Park in well lit area. While parking in an isolated spot may reduce the risk of a door ding, a criminal looks for cars parked out of the way in order to help ensure less attention is drawn to them.
- Turning on outside driveway and porch lights are still the cheapest form of security.

These simple steps should be used whenever you park your car, whether you are just "running in for a minute" or parking for the evening. ### Honey, "Where's My Car?"

During the winter months many citizens start their vehicles and let the engines run while sitting in the driveways or parking lots unattended. Last year several cars were stolen or taken for a joyride. This behavior is not only dangerous but also illegal regardless if the car is locked or not. You can also be held responsible in civil court for damages or injuries if your car is taken and involved in an accident. The bottom line is, never leave your car running unattended.

### **Winter Driving Tips**

With winter upon us, it is important we remember safe winter driving tips. Even experienced drivers can find their nerves and skills tested by the winter road conditions in the Chicagoland area. Here are some tips to help you drive safely as the weather turns cold and nasty ...

- Keep your vehicle properly maintained.
   A properly functioning vehicle is key to surviving winter driving.
- Be prepared for the unexpected emergency and always carry a First Aid kit, ice scraper, snow brush, matches, candles, flashlight, warning triangles or flares, bag of sand, blanket, gloves, emergency HELP sign, and cell phone (if you have one) in your vehicle.
- Watch for hazardous road conditions.
   Take extra care when driving on icy roads and watch out for hard to see patches of ice (black ice), especially in shady spots and over bridges.
- Keep a safe distance of at least five seconds behind other vehicles.
- Use your headlights during overcast and gloomy fall days.
- Remove all snow and ice from all windows of your vehicle before starting your drive.
- Keep your windshield washer reservoir full to help keep your windshield clear.
- Finally, SLOW DOWN! Most car accidents are caused by excessive speed.

### **Health Screening Clinic**



#### **Income Tax Time is Here**

Free Income Tax assistance will be available for seniors over the age of sixty. Trained volunteer counselors will assist in preparing Federal and State tax forms. Appointments must be made in advance by calling the Human Services Department at 847/870-5680. Tax preparers are trained to complete standard forms, individuals with very technical tax situations are advised to seek the services of a professional preparer.



### Senior Exemption and Senior Tax Freeze Applications for Real Estate Taxes

Homeowners who are over 65 years of age and have a household income of less than \$55,000 must file a Senior Tax Freeze Exemption application. The application requires income information and your signature to be notarized. If your income is over \$55,000 you still qualify for the Senior Homestead Exemption and that application must be filled out and sent in EVERY YEAR. The applications are usually sent out to homes that have applied for the exemptions(s) in past years. If you do not receive your application in the mail by March 1st, contact our office or your township assessor's office to have one mailed out to you. Human Service staff is available to assist with the forms and/or notary services by appointment. Applications for the exemptions should be filled out, signed and mailed in as soon as possible in order to have the exemption applied to your second installment of your real estate taxes.

To qualify for the taxable year 2012, you must meet all of the requirements above and Use the property as a principal place of residence on January 1, 2011 and January 1, 2012, be liable for the payments, and own the property, or have a legal, equitable or leasehold interest in the property on January 1, 2011 and January 1, 2012.




