RANDHURST REDEVELOPMENT MOVING FORWARD

Casto Lifestyle Properties is in the process of transforming Randhurst Shopping Center into Randhurst Village - a lifestyle center that will include a new state of the art AMC Theater, a hotel and over 250,000 square feet of retail/restaurant space. Carson's, Costco, Bed Bath and Beyond and all of the existing outlot retailers remain open for business during construction.

Casto is nearly complete with interior demolition work within the mall structure and is set to initiate full demolition by early July. While it may appear that little activity is taking place on the site, Casto has been very busy undertaking a complicated demolition project. In order to take down the mall structure, the Carson's and Bed Bath and Beyond buildings had to be "disconnected" from the mall. This required new infrastructure (heating, air conditioning, fire protection systems and all utilities) to be constructed for these buildings as they were connected to the mall's main utility system. *Continued on Page 3*



Did You Purchase Your Vehicle Sticker?

The deadline for displaying 2009-2010 vehicle stickers was April 30. The Police Department is now issuing citations to owners of locally registered vehicles on which 2009-2010 vehicle stickers are not displayed. The penalty will not initially apply to new Village residents or to residents who have purchased replacement vehicles after May 1. In either case, you have 30 days to purchase your sticker. During the grace period, proof of purchase or move-in date will be required to assure that a surcharge penalty is not imposed. If you change vehicles during the year, a transfer is required. In addition, a new loading dock had to be constructed for Carson's since their loading dock that has been located in the lower level of the mall will be eliminated when the mall is demolished. Now that this demolition work is nearly complete, Casto is set to move full speed ahead with the project.

Construction has begun on a new multi-tenant outlot building along Kensington Road where the Egg Factory Restaurant was previously located. Chipotle Restaurant and Five Guys Burgers and Fries have signed leases to locate in this building and they expect to open for business by the end of this year. The grand opening of the new lifestyle center is tentatively scheduled for the spring of 2011.

Other Major Development Projects

Walmart

Walmart is nearly complete with their extensive renovation and is planning a grand opening by the end of July. They have expanded and completely refurbished their store and will now offer a grocer component at this location. The Mount Prospect facility will be their prototype location for their new smaller superstore concept.

Stay Fit Food Market

Stay Fit Physical Therapy will be opening a food market in the downtown adjacent to their fitness facility at 127 W. Prospect Avenue. They will initially sell dairy products, pre-packaged foods, natural and organic products and European and Mediterranean breads. Later this fall they will introduce a "fresh" grocery and baked goods.

Parking Spaces Available

Village Hall Deck Overnight Guest Parking Passes Now Available Parking on Village streets between the hours of 2 am and 6 am is prohibited. Overnight guest parking is permitted in the Village Hall Parking Deck on Level 4 in Spaces 282-316. Parking passes for the Village Hall Parking Deck are available to any resident of Mount Prospect for their overnight guests.

Each guest pass is valid for 3 days (pass will be stamped with valid dates) and an applicant/household/vehicle may have 3 consecutive passes for a total of 9 consecutive days. Passes must be clearly displayed in the rear window of the vehicle. The passes will be administered on a first come, first served basis. They are available in the Finance Department on the first floor of Village Hall, Monday through Friday 8:30 am - 5:00 pm.

Business/Commuter Spaces

Parking spaces are available for yearly rental in the Wille Street Parking Lot (near the downtown Metra Train station). Please note: overnight parking is not allowed. The spaces are available to Mount Prospect residents or Mount Prospect business owners/employees only. A specific space in the lot is assigned for one year and can be renewed annually. The cost per space is \$360/year for residents.

Overnight Residential Parking

There are also parking spaces available for a fee to residents of the Shabonee Trail and Mount Prospect townhome associations. Certain restrictions apply. For information or to purchase a parking permit, call Lisa in the Finance Department at 818-5277.

Direct Debit Program

Besides mail, the Village offers another payment option for your Water/Sewer and Refuse utility bill. You may opt to pay through direct debit of your checking or savings account. The funds will be withdrawn on the due date, thus avoiding late fees. Authorization forms are available on our website, www.mountprospect.org. Listed below are some FAQs about the program. If you have further questions, please contact the Village at 392-6000.

Q. Is there a fee to utilize the Direct Debit Program?

A. No; there is no fee associated with the Direct Debit Program.

Q. When will my initial Direct Debit occur?

A. Once your completed enrollment form is received, it will undergo a "prenotification" process where a test transaction (zero dollar amount) is created and used to verify the accuracy of the account information provided. You will know when automatic direct debit payments are scheduled to begin when you receive your utility bill and it indicates "Bank Draft – Do Not Pay". Please continue to make payments until that time.

Q. When will funds be debited from my account?

A. The determined amount will be transferred from your bank account on the due date listed on the utility bill. If the due date falls on a weekend or holiday, your account will be debited on the following business day.

Q. Who is responsible for the availability of funds?

A. You are responsible for having enough money in the designated account on your payment date for the actual or estimated usage billed. Usage will be estimated based on previous history if an actual reading was not received. It is your responsibility to review your bill prior to the automatic bank draft date. If you foresee an issue with the amount to be debited, it is necessary for you to contact us at 392-6000 at least ten (10) days prior to the scheduled bank draft date. As with checks returned for nonsufficient funds, there is a \$20 NSF charge on all returned items. Direct Debit Pay will be canceled if two payments are returned within a twelve (12) month period.

Q. Will I Have A Record of Payments?

A. Your monthly bank statement will indicate the amount and date of your automatic transfer. If a question arises regarding your transfer or if the amount differs from your bill, you must notify us and your financial institution within sixty (60) days of the date of the questioned statement. Your financial institution will advise you of your rights concerning the error.

Q How Do I Submit My Water Meter Reading?

A. If you choose to take advantage of the direct debit program, it is still necessary to provide a water meter reading. You may submit the reading via our website @ www.mountprospect.org by clicking on quick links and scrolling down to water meter reading; or submit the reading via your bill stub; or submit the reading verbally by calling 392-6000.

Since the last publication of the Mount Prospect Newsletter, the Village Board of Trustees has enacted the following ordinances from February 18, 2009 through May 19, 2009:

5726 amends Chapter 18 (Traffic) of the Village Code by implementing components of the Village's "Residential Intersection Traffic Control" and "Residential Speed Limit" program for Zones 1, 2, 5 and 6;

5727 amends Chapter 13 (Alcoholic Liquors) of the Village Code by deleting the current Chapter 13 in its entirety and inserting a new Chapter 13 with comprehensive revisions that address current business practices associated with the service of liquor;

5728 amends Chapter 9 (Pubic Utilities Pavement and Tree Regulation) of the Village Code by modifying the Village's right-of-way access control code;

5729 grants a Conditional Use permit to operate a community center and school for property located at Niagara Educational Services, Inc. 501 Midway Drive;

5730 grants a Conditional Use permit (drive through) and Variation (parking spaces) for property located at 800 North River Road;

5731 amends Chapter 10 (Licenses and Permits) of the Village Code by modifying the appeal procedures for license hearings;

5732 amends Chapters 8 (Village Government Miscellaneous Provisions), 13 (Alcoholic Liquors), 18 (Traffic) and 23 (Offenses and Miscellaneous Regulations) to correct a previously amended ordinance submitted for codification: 5733 authorizes the Village to reserve its 2009 private activity bond volume cap for future use;

5734 amends Chapter 13 (Alcoholic Liquors) of the Village Code by deleting one (1) Class "R" liquor license issued to Mt. Prospect Park District, 600 South See Gwun Avenue and deletes one (1) Class "S" liquor license issued to Old Orchard Country Club Restaurant, 700 West Rand Road;

5735 amends Chapter 13 (Alcoholic Liquors by deleting one (1) Class "W" liquor license issued to Los Arcos, Inc., d/b/a Taqueria Los Arcos, 1707 West Algonquin Road and adds one (1) Class "F1" liquor license to Los Arcos, Inc., d/b/a Taqueria Los Arcos, 1707 West Algonquin Road;

5736 amends the Annual Budget adopted for fiscal year commencing January 1, 2009 and ending December 31, 2009;

5737 amends Chapter 13 (Alcoholic Liquors) by deleting one (1) class "F-2" liquor license issued to Breezes of Mexico, Inc., d/b/a Breezes of Mexico, 1742 East Kensington Road;

5738 grants a Conditional Use permit (circular drive) for property located at 915 Hi Lusi Avenue;

5739 designates representatives to the Northwest Suburban Municipal Joint Action Water Agency (JAWA) for the Village of Mount Prospect.

Building Division - FAQs

Handrails Required By Code

Any time a set of steps (including patios, stoops, sets of stairs), has more than 2 risers, a handrail is required by Code. There are several guidelines and regulations regarding stairway width, stair height (riser), stair depth (tread), and where your handrail should be located. The Stairway Manufacturers Association has published an excellent visual interpretation guide on stairs and handrails, which can be found on the Village web site, www.mountprospect. org, under the Building Division.

Fire Pits

The Village currently does not have regulations regarding portable (non-permanent) fire pits; but must advise that the manufacturer's specifications and instructions be followed carefully. Burning of trash, yard waste, and other debris is NOT permitted. Additional questions regarding fire pit safety can be directed to the Fire Prevention Bureau at 818-5253.

Permanent or built-in BBQ's, grills, outdoor fireplaces, and fire pits DO require review by Village Staff. These items are reviewed on a case-by-case basis. Please contact the Building Division at 870-5675 with questions regarding these types of projects.

Swimming Pools

In accordance with Village Code a permit is required for any swimming pool, hot tub or spa, or man-made pond over 24 inches in depth. Pools and ponds are reviewed by the Building Division, Planning Division, and Engineering Department. This means that plan review can take up to thirty (30) business days for review. Please contact the Permit Coordinator with further questions at 818-5396.

Community **Development**

Community Development Block Grant Home Improvement Programs

The Village of Mount Prospect currently provides two home-improvement programs: the Single-Family Rehabilitation Loan Program and the Home Weatherization Grant Program. Both programs are funded through Community Development Block Grant (CDBG) funds allocated to the Village by the U.S. Department of Housing and Urban Development (HUD).

The Single-Family Rehabilitation Loan Program provides an interest-free loan up to a maximum amount of \$25,000, which is repaid upon sale or change of title of the property. Loans can be used to increase energy efficiency, replace furnaces and water heater, correct code violations including electrical, plumbing and roof repairs and to make handicapped accessible improvements.

The Home Weatherization Grant Program provides up to \$1,500 as a matching grant to be used for energy efficiency improvements. Grants can be used to install insulation, entry doors, weather stripping, energy efficient furnaces and water heaters, and other items that can help save on the cost of home utilities.

Applicants may choose one of the two available programs and must meet the programs qualifications. In order to be eligible, applicants must live within the corporate limits of Mount Prospect, have owned and occupied their home for at least one year prior to applying, and meet HUD's current income limits (see table on left).

Community Development Block Grant Five-Year Consolidated Plan - Your Opinion Counts!

CDBG funds are granted to the Village by the Department of Housing and Urban Development (HUD). These funds are intended to create viable communities by providing decent housing, a suitable living environment and expanded economic opportunities for low- and moderate-income persons.

The Village is in the process of developing the Five-Year Consolidated Plan (2010 – 2014), which is a requirement of receiving HUD funding. This plan identifies the Village's priorities and objectives for addressing the community's needs for the next five years. Currently, the Village's Five-Year Consolidated Plan (2005 – 2009) includes the following priorities: Affordable Housing; Homeless/Continuum of Care; Other Special Housing/Non-Homeless Needs; Youth Programs; Public Service Needs. As part of this process, the Village is seeking public input to determine whether the priorities listed in the current five-year plan are still appropriate. We encourage you to contribute to this process by taking our on-line survey at www.mountprospect.org or by filling out a survey, available at Village Hall. Comments must be received by July 6.





Property Maintenance Guidelines

To preserve the community, the Village routinely inspects the community for exterior code violations that detract from the community's appearance and interfere with residents' safety and enjoyment of their home. Annually, an inspector walks neighborhoods and requests repairs and correction of property maintenance problems. If you have a home in your neighborhood that needs attention please call Community Development at 870-5668. The following is a summary of the regulations.

Sanitation

- Exterior areas must be maintained free of garbage and rubbish.
- Garbage and yard material stored in approved Village containers.
- Garbage and yard material containers must be set out after 4:00 P.M. on the previous day of collection. After collection, the containers and improperly prepared or unaccepted waste must be removed from the curb.

Building Surfaces

• Siding, roofs, gutters, windows and doors shall be free of holes, rotting material, and where necessary painted for protection from the elements.

Accessory Structures

 Garages, sheds, fences, decks, gazebos, pools, and fences shall be structurally sound, be free of holes, rotting material, and where necessary painted for protection from the elements.

Walkways and Driveways

- Driveways must be free of potholes, large cracks, loose gravel, and trip hazards.
- Sidewalks and patios must be maintained and not pose a hazard.

Vehicles

- All vehicles including recreational campers, boats and trailers must be parked on the driveway or in the garage.
- All vehicles must be licensed and have a Village sticker.
- Inoperable vehicles and cars under repair or overhaul must be in the garage.
- Parking over sidewalks is prohibited.

Animals

- Animals are not permitted to stray onto others' property.
- Dogs must be leashed or enclosed by an adequate fence.
- Animals must not disturb the peace.
- When walking your dog you must have a device to remove defecation and remove the defecation.

Vegetation

- Grass and weeds must be maintained below eight inches in height.
- Privately owned bushes and trees must not obstruct the public sidewalk.
- Dead trees must be removed.

Front Porches

The Village is very supportive of proposals to improve a home by adding a porch, and has made an effort to make the porch approval process easier for residents. If the porch meets all applicable zoning setback and other bulk regulations a building permit is all that is required. For homes that are currently constructed up to the required front yard setback, Conditional Use approval is required prior to the issuance of a building permit for the porch.

A porch can be added to the front of a home, but requires a Conditional Use if it breaks the "front yard setback", an invisible line, typically 30 feet back from the property lot line. With approval of a Conditional Use, a porch may encroach to no more than five feet (5') into the required front yard and requires the front porch to be unenclosed.

To ensure that the porch meets the standards for a Conditional Use, you must file an application with the Community Development Department. Applications are available on the Village website and at the Community Development Department. The Conditional Use review process for an unenclosed porch in the front yard is an administrative review process and can take up to 30 days from submittal.

Public Works Employees Win Regional Snow Plow Contest

Congratulations to Public Works Department employees Kurt Aspen and Mike Stephenson! Kurt and Mike captured First Place in the 2009 American Public Works Association (APWA) Chicago Metro Chapter Snow Plow Rodeo held at the Schaumburg Renaissance Hotel and Convention Center in Schaumburg, on May 21.

Over 30 2-person teams from public works departments as near as Arlington Heights to as far away as Champaign competed in the 1-day event. The competition included:

- An obstacle course a timed event that simulated real life situations often encountered by snow plow drivers including avoiding parked cars and plowing along a curve.
- A written test that assessed the drivers' knowledge of Commercial Drivers License (CDL) regulations and Illinois Secretary of State Rules of the Road.
- A disabled vehicle inspection that required each driver to inspect a parked snowplow vehicle that had been purposely disabled by a fleet mechanic. Each driver was required to identify 5 major defects that would prevent the vehicle from being utilized in snowplowing operation.

Kurt and Mike earned 667 points out of 900 points possible for all three events. The Village of Bolingbrook received 2nd place with 621 points, and the Village of Algonquin placed 3rd with 604 points. The skill and dedication of Kurt, Mike, and the rest of our Public Works employees, are the reason Mount Prospect has some of the cleanest winter-time streets in the area. Now they have the trophy to prove it!

Police Department's Traffic Safety Efforts Earn Statewide Recognition

The Mount Prospect Police Department placed 3rd in the municipal agency division (50-99 officers) of the 2008 Illinois Traffic Safety Challenge. The department submitted a comprehensive document summarizing its efforts in the traffic safety arena throughout all of 2008. "The submission itself underscores the breadth and width of the police department's traffic safety efforts and demonstrates the value of the department's Traffic Unit," said Chief John Dahlberg. "The Traffic Unit Supervisor, Sergeant Mike Eterno and Operations Commander, Timothy Janowick teamed up to produce an exceptional submission on behalf of the department."

The Illinois Traffic Safety Challenge is coordinated by the Illinois Association of Chiefs of Police Traffic Committee, and is designed to challenge police departments, county sheriff agencies, state police districts and other law enforcement agencies to tackle traffic safety problems in their jurisdictions in unique ways. Agencies need to document their policies and procedures, officer training, traffic safety recognition programs, public information and education efforts, crash data and effectiveness information.

Applications are judged by members of the Illinois Chiefs Traffic Committee. and are then forwarded to the International Association of Chiefs of Police for consideration in the National Law Enforcement Challenge awards, which are presented in October at the International Association of Chiefs of Police Annual Conference.

Leave the Fireworks to the Professionals

Each year during the Fourth of July holiday thousands of people, mostly children, are seriously injured in fireworks-related incidents. More than 1,500 eye injuries fireworks-related occur each year. Children and youth under 20 sustain 47 percent of these injuries. Sparklers accounted for one-third of the injuries to children under five years old. Rockets and bottle rockets were related to more than three-quarters of the most serious injuries.

Because of the hazards and injuries associated with fireworks, the Village of Mount Prospect prohibits all types of fireworks including sparklers. Sparklers reach temperatures of up to 1800 degrees Fahrenheit and remain hot enough to cause serious burns even after they are extinguished. Fireworks are also especially dangerous to children because they entice children to play with matches.

The Mount Prospect Fire Department wishes all a happy and safe 4th of July celebration and requests everyone to leave the fireworks to the professionals and enjoy the professional fireworks display at Melas Park.

High Rise Safety

Whether you live, work, visit, or even stay in a high rise hotel during your summer travels, it is important to be prepared for any type of high rise building emergency. A high rise building may consist of apartments, condominiums, hotels, health care facilities or offices. In Mount Prospect, buildings four stories or greater can be considered a high rise building. Building features such as smoke alarms, automatic fire sprinklers, and modern construction features in today's high rise buildings produce safe facilities to live, work and visit. In the event of an emergency, the Mount Prospect Fire Department offers the following high rise emergency guidelines:

- Always make a habit to familiarize yourself with two exit routes out of the building. Remember when you check-in a hotel or visit an office in a high rise building, take a few moments to find the two closest exits.
- If a fire is in your condominium, office suite or hotel room, leave the unit closing the door behind you.
- Proceed to the nearest stairwell. If a fire alarm pull station is present, pull the handle to set off the building's fire alarm.
- Proceed down the stairs or to the exit, closing the door behind you. If you are
 unable to walk down the stairs, remain in the stairwell off to the side to enable
 others to evacuate. Remain calm and wait for help. If there is a working cellular
 telephone available, call 911 and tell them exactly where you are. This information
 will be relayed immediately to the firefighters on the scene. Once you have exited
 the building call 911.
- If you are in a hallway and there is smoke or fire, proceed to the nearest stairwell. If there is no smoke in the stairwell proceed down the stairs or to the exit closing the door behind you. If you are unable to walk down the stairs, remain in the stairwell off to the side to enable others to evacuate. Remain calm and wait for help. If there is a working cellular telephone available, call 911 and tell them exactly where you are. This information will be relayed immediately to the firefighters on the scene.

The blood test will consist of a Lipid Panel (T Chol, Triglycerides, LDL, HDL), Chemistry Profile (Albumin, BUN, Creatinine, Electrolytes, T Bili, Calcium, Alk Phos, T Protein, SGOT, Glucose) and a Complete Blood Count for \$30.00 for all three tests. For men, a PSA (prostate cancer screening) blood test will also be offered at \$20.00. Payment will be accepted at the time of the test. Appointments for the blood test must be made in advance by calling 1-877-RES-INFO or 1-877-737-4636 beginning July 15, 2009. Test results will be sent directly to your home.

NOTE: Due to the Annual Blood Test held on Friday, September 11, the Thursday, September 10 Cholesterol Screening Clinic will be canceled.

Family Stress and Financial Concerns

The Village of Mount Prospect is dedicated to providing you with an adequate and dependable supply of safe drinking water. As part of this effort, we have prepared this Consumer Confidence Report (CCR). This report will provide residents and businesses served by the Village-owned water distribution system with the information necessary to make prudent decisions about how they use tap water. Please note, information in this CCR does not pertain to Illinois American Water Company water customers. Illinois American Water Company will prepare and distribute a separate CCR for their water customers and they can be reached at 1-800-422-2782.

This report is a requirement of the 1996 Safe Drinking Water Act amendments. It summarizes where your water came from, what it was made of, and how it compared to the standards established by regulatory agencies. Information about water consumed during the reporting year will be made available in a CCR scheduled for distribution during the following year. CCRs will be published in July of each year.

Information in this report describes water consumed during the 2008 calendar year. We are happy to report that the Village-owned water system had no water quality standard violations last year.



Where do we get our water?

Our water supply comes from Lake Michigan, one of the five Great Lakes. The lake water is treated and purified by the City of Chicago, Department of Water Management (312-744-6635). The finished $drinking\,water is\,then\,pumped\,to\,the\,Northwest\,Suburban\,Municipal$ Joint Action Water Agency (NSMJAWA) reservoirs. NSMJAWA then pumps the water to Mount Prospect and six (6) other northwest suburban communities via large water transmission mains. Three of these mains terminate at receiving structures in Mount Prospect. The structures are situated at various locations throughout the Village. Prior to receiving lake water, the Village pumped water from as many as 17 public deep wells located throughout the Village.



By volume, Lake Michigan is the second largest of the Great Lakes. Hydrologically, it is inseparable from Lake Huron. The total shoreline, including all its islands, is almost 1,640 miles long. All 63 miles of shoreline within Illinois are considered to be in good condition.





animals or from human activity. Possible contaminants consist of:

- Microbial contaminants such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- · Inorganic contaminants such as salts and metals, which may be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and may also come from gas stations, urban stormwater runoff, and septic systems; and
- Radioactive contaminants, which may be naturally-occurring or be the result of oil and gas production and mining activities.


Untreated lake water has the potential to contain these types of contaminants. However, it is important to realize that these materials can be found throughout nature to some degree. Their presence does not necessarily mean that there is a health risk associated with our source water. Rather, the most important factor to consider is how much of a particular contaminant can be found in our source water.

Fortunately, the quality of raw, untreated Lake Michigan water is good. This means that conventional treatment methods, such as disinfection with chlorine, coagulation, and sedimentation with sand filtration can be used effectively to produce large quantities of safe drinking water.

Has an assessment been made of Lake Michigan water?

Yes. The Illinois Environmental Protection Agency (IEPA) completed a Source Water Assessment Program (SWAP). The IEPA implemented the SWAP to assist with watershed protection of public drinking water supplies. The SWAP inventories potential sources of contamination and determines the susceptibility of the source water to contamination. The Illinois EPA considers all surface water sources of community water supply to be susceptible to potential pollution problems. The very nature of surface water allows contaminants to migrate into the intake with no protection only dilution. This is the reason for mandatory treatment for all surface water supplies in Illinois. Chicago's offshore intakes are located at a distance that shoreline impacts are not usually considered a factor on water quality.

At certain times of the year, however, the potential for contamination exists due to wet-weather flows and river reversals. In addition, the placement of the crib structures may serve to attract waterfowl, gulls and terns that frequent the Great Lakes area, thereby concentrating fecal deposits at the intake and thus compromising the source water quality. Conversely, the shore



intakes are highly susceptible to storm water runoff, marinas and shoreline point sources due to the influx of groundwater to the lake.

Who decides if water is safe to drink?

In order to make certain that tap water is safe to drink; the United States Environmental Protection Agency (USEPA) and the Illinois Environmental Protection Agency (IEPA) prescribe regulations that limit the amount of certain contaminants in the water distributed by public water systems. All public water systems, including the City of Chicago and the Village of Mount Prospect, must monitor their systems and comply with these regulations. Failure to do so is a violation of federal and state laws and can result in severe penalties. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Is Mount Prospect's drinking water safe?

Yes it is. Last year, Mount Prospect complied with all of the federal and state regulations pertaining to the storage and distribution of drinking water. No violations were recorded. The table on Page 3 summarizes the tests that were performed to ensure compliance with water quality standards. Page 4 has additional tables and outlines the definitions associated with this information.

The City of Chicago conducted a number of additional water quality tests as well. In fact, they routinely performed over 70 different water quality tests as part of their raw water treatment process. The results of all of these tests complied with federal and state drinking water regulations. No violations were recorded. In addition to both the Village and the City of Chicago tests, the Village's water distributor, the Northwest Suburban Municipal Joint Action Water Agency (NSMJAWA) also performs a number of water quality tests. No violations were recorded. The results of NWSMJAWA and the City of Chicago's analyses are available to the public and are on file at the Mount Prospect Public Works Facility.

Are there any problems with lead in our water?

No. Village tests for lead and copper content indicate that there are no unhealthy levels of either contaminant in our drinking water.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Village of Mount Prospect is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has

been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available form the Safe Drinking Water Hotline or at http://www.epa.gov/safewater/lead.

Presently, the Village tests for lead and copper content once every three (3) years. We collect samples from the taps of 30 private homes. In order to avoid corrective action, the samples at the 90th percentile must be less than the Maximum Contaminant Level (MCL) established for each contaminant. The table on page 3 summarizes the results of our last round of lead and copper testing, which we completed in 2008. We will test for lead and copper again in the summer of 2011.

It should be noted that infants and young children are more vulnerable to lead in drinking water than the general population. It is possible that lead levels in your home may be higher than in other homes due to the types of materials used in your home's plumbing system. If you are concerned about elevated lead levels in your water, you may wish to have it tested at a local laboratory. Flushing your tap for 2 minutes before using the water will also reduce your risk of lead exposure. ppb - Parts Per Billion (same as ug/l) or one ounce in 7,350,000 gallons of water

#pos/mo - This represents the number of positive samples per month.

%pos/mo - This represents the percentage of positive samples per month.

AL - Action Level: The concentration of a contaminant that triggers treatment or other required actions by the water supply.

ND - Not Detectable: Not found at the testing limits.

NA - Not Applicable.

TT - Treatment Technique.

%<0.5 NTU - Percent of samples less than .5 NTU.

"Amount" column is an average of all sample result data collected during the CCR calendar year.

NTU - Nephelometric Turbidity Unit, used to measure cloudiness in the drinking water.

"Range of Detections" represents a range of individual sample results, from lowest to highest, taken during the CCR calendar year.

"Date of Sample" represents whether the sample was collected during the CCR calendar year or the last time IEPA required samples to be collected. If no date appears, then the sample was collected during the reporting year.

"pCi/L" – Picocuries per liter, used to measure radioactivity.

Turbidity - This is a measurement of how cloudy the water appears. It is monitored because it is a good indicator of water quality and the effectiveness of our filtration system and disinfectants.

Sodium - There is no MCL for sodium. However, individuals on a sodium restricted diet should consider consulting a physician about this level of sodium in the water.

Vulnerable Populations

Some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. USEPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the USEPA's Safe Drinking Water Hotline at 1-800-426-4791.

In order to ensure that tap water is safe, USEPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. 
